

COURTROOM TESTIMONY

Brian Sallee is a Detective with the Albuquerque Police Department and works on the APD Meth Program. Mr. Sallee has been a sworn law enforcement officer since 1980 and has worked narcotics since 1989. Brian spent over 25 years working narcotics units during his career including undercover, surveillance, search warrants, informant handling, reversal and buy/bust operations, and clandestine labs. He is qualified as an expert witness for narcotics investigations. He instructs narcotic classes for the Albuquerque Police Academy, the DEA, the International Association of Undercover Officers, and for police training organizations throughout the United States. Brian holds a Bachelor's Degree in Police Science from New Mexico State University. He is author of the book, "The Methamphetamine Handbook: What You Need to Know" and co-author of "Narcotics Investigations: Working and Surviving."

Scott Rosenwasser served as an Assistant State Attorney, Chief of Felony Division for the Pinellas County State Attorney's Office in Clearwater, Florida and he has been an Assistant State Attorney for over twenty years. As a felony prosecutor for over nineteen years, Mr. Rosenwasser has prosecuted hundreds of narcotics cases and drafted search warrants used in narcotics investigations and has also prosecuted numerous other types of felony cases. Since 2005, he has been teaching courtroom testimony throughout the United States with the Center for Public Safety Innovation at St. Petersburg College. Mr. Rosenwasser graduated from Stetson University College of Law, Cum Laude, in 1995. He also graduated with honors from the University of Florida in 1991 where he obtained a degree in Business Administration with a specialization in Finance.
